

RESOLUTION 2013-S

**A RESOLUTION OF THE EATONVILLE TOWN COUNCIL APPROVING THE
REFINANCING OF AN EMERGENCY INTERFUND LOAN PROVIDING FINANCING
FOR THE CURRENT EXPENSE FUND.**

WHEREAS the Eatonville Town Council approved a loan from the Electric Fund to the Current Expense Fund on November 13, 2007 in the amount of \$100,000.00; and

WHEREAS the term of the loan is not in compliance in accordance with the Washington State Auditor's office BARS Manual,

THEREFORE, BE IT RESOLVED by the Council of the Town of Eatonville as follows:

Section 1. The Council hereby authorizes the refinance of a interfund loan in the amount of \$60,216.84, from the Electric Fund to the Current Expense Fund originally approved by Resolution 2007-LL-B.

Section 2. The rate of interest to be paid on the loans approved shall be per annum 3%. Repayment of loan and interest approved shall be paid Semi annually on or before June 1st and December 1st each year beginning June 1, 2013 and ending on or before December 1, 2015.

RESOLUTION 2007-LL-B

A RESOLUTION OF THE EATONVILLE TOWN COUNCIL APPROVING AN EMERGENCY INTERFUND LOAN PROVIDING FINANCING FOR THE CURRENT EXPENSE FUND.

WHEREAS the Town of Eatonville has declared a financial emergency deficit for the Current Expense Fund.

NOW, THEREFORE BE IT RESOLVED that this Council of the Town of Eatonville hereby:

Section 1. The Council hereby authorizes a loan from the Electric Fund to the Current Expense Fund for the sum of \$100,000.00 to bring this fund out of a negative status. The Current Expense Fund did not receive projected revenues in 2007 due to lack of building in the Town.

Section 2. The rate of interest to be paid on the loans approved shall be per annum 4.65%. Repayment of loan and interest in the amount of \$11,316.67 shall be paid annually on or before June 30, 2008 and ending on or before June 30, 2023.
