**In addition to the initial electrical system fee, for all new electrical customers the fee shall be \$600.00. Additionally all new electrical service customers shall pay the costs of providing electric service from the present distribution lines to the customer's premises.**

**Resolution 2015-U – Deferral of Connection Fees** – Utility connection fees will not be required for issuance of the building permit. Utility Connection fees (electrical, water, sewer and storm drainage) shall become due only as a prerequisite for obtaining an occupancy permit.

Based on a \$ 246,722.00 SFR valuation - Permit fees are approximately \$ 13,950.79.

### Physical Construction Issues:

Each site is individual, so construction cost will vary. In any case, construction budgets should include sidewalks, (EMC 12.04.180), Stormwater Management and Erosion control (EMC 16.54.020) and driveway paving (EMC 18.05.090 C)

**\*ESTIMATE OF FEES DOES NOT INCLUDE PLUMBING OR MECHANICAL PERMITS.**

Plumbing and Mechanical permits are 15% of the building permit fee.
