### DEPARTMENT HEAD/COUNCIL COMMITTEE/BOARD/COMMISSION REPORT

- **a. Police Report** December report is on file with the Town Clerk. Chief Witt reported that he is working on the 2016 Training schedule, changing his vehicle graphics to Eatonville Police Department, getting his new Eatonville uniform and getting his Certifications up to date.
- b. Fire Report- December report is on file with the Town Clerk. Assistant Fire Chief Yount reported that Bob Vellias will be retiring on April 1, 2016 and assured the Town Council that there will be no changes to how the Department is being run due to his retirement. He also reported that the Department has been involved with Town events, will be holding an EMT class in March, continues to meet with the CERT group quarterly, is working on a Mutual Aid Agreement with District 23 and has been dealing with slick roads due to the weather. He thanked the Town crew for doing a good job with de-icing the streets.
- **c. Public Works Report-** December reports are on file with the Town Clerk.
- Mayor Report- Mayor Schaub reported that he attended the Homes for Our Troops Community Kickoff on Saturday. The Homes for Our Troops organization will be building a mortgage-free, specially adapted home in Triangle Estates for SSG Sam Shockley, a Veteran who was disabled while serving in Afghanistan. He also reported that the Right of Way phase of SR161 project is in process, he is working on a job description for a Public Works Director/Administrator position and will bring it to Council for approval and that Councilmember Powell resigned his position on the Town Council because he moved out of the Town limits.

# **ORDINANCE 2015-20 Second Reading**

An Ordinance of the Town of Eatonville, Washington, amending Chapter 9.33 of the Eatonville Municipal Code by establishing new sections prohibiting hunting within the Town limits and providing penalties for violations.

Town Clerk Kathy Linnemeyer read the Ordinance by title into the record.
