

**EATONVILLE TOWN COUNCIL  
MINUTES OF REGULAR COUNCIL MEETING**

**TIME:** 7:00 PM

**DATE:** September 14, 2015

**PLACE:** Eatonville Community Center

**CALL TO ORDER**

Mayor Schaub called the meeting of the Eatonville Town Council to order at 7:00 p.m.

**ROLL CALL**

Town Clerk Kathy Linnemeyer called the roll. The following were:

Present: Council members James Schrimpsheer, Abby Gribi, Bob Walter, Brenden Pierce and Andy Powell.

Also Present: Town Clerk Kathy Linnemeyer, Town Administrator Doug Beagle, Treasurer Lori Smith, Fire Chief Bob Vellias and Police Chief Jim Heishman.

**OPENING CEREMONIES**

Mayor Schaub led the assembly in reciting the Pledge of Allegiance to the American Flag.

The Town Clerk read the Mission Statement for the Town of Eatonville:

“The Town’s mission is to create, provide and administer municipal services while protecting the present and future health, safety, and general welfare of the community.”

**APPROVAL OF AGENDA/SET TIME RESTRICTIONS**

Councilmember **Schrimpsheer** moved approval with a three minute time restriction and was seconded by Councilmember **Gribi**. All were in favor.

**COMMENTS FROM CITIZENS**

Citizen Shanna Littrell expressed concerns about two known drug houses in town and stated that she is concerned for her safety. She stated that she has seen people with weapons, an increase in garbage at the residences and people living in recreational vehicles. She also heard that people were bow hunting in Town and asked if bow hunting is allowed inside the Town limits. She feels that allowing bow hunting in town is a safety issue.

Councilmember **Schrimpsheer** announced that the Public Safety Committee will discuss bow hunting at the next meeting on October 6, 2015. Meetings are held at the Visitor Center and start at 6:30 pm.

Councilmember **Gribi** moved approval and was seconded by Councilmember **Walter**. All were in favor.

### DEPARTMENT HEAD/COUNCIL COMMITTEE/BOARD/COMMISSION REPORT

- a. **Police Report** – August report is on file with the Town Clerk. Chief Heishman thanked Council for approving the purchase of the lit crosswalks. He has received a lot of good feedback about them since school has started. He also stated that bow hunting will be on his agenda for discussion at the next Public Safety meeting.
- b. **Fire Report** – August report is on file with the Town Clerk. Chief Vellias announced that the Public Safety committee meets the first Tuesday of each month. The meetings are held at the Visitor Center and start at 6:30pm. He also reported that the consolidation of Eatonville Fire Department and South Pierce Fire and Rescue is going smoothly.
- c. **Public Works Report** – August reports are on file with the Town Clerk.
- d. **Park/Cemetery Committee-** Councilmember **Walter** announced that the Park/Cemetery committee met and discussed the number of cremations allowed in a plot, requiring proof of transfer of ownership, price to purchase back plots and scheduling of burials on weekends. Councilmember **Gribi** requested that the Committee review usage fees for Town parks.
- e. **Mayor Report** – Mayor Schaub reported that the scheduled maintenance by Bonneville Power Administration on the substation took a couple hours longer than planned. He feels that the Town needs to consider a long term plan for an additional electric feed into the Town. He also reported that the Planning Commission held a public hearing on an Ordinance to allow ATVs to drive on Town streets and it will be forwarded to the Town Council.

### RESOLUTION 2015-X

A Resolution of the Town of Eatonville, Washington, authorizing the Mayor to execute the first addendum to the September 25, 2012, interlocal agreement between the Town of Eatonville and the City of Bonney Lake for the providing of facilities and personnel for the Municipal Court of Eatonville.

Town Clerk Kathy Linnemeyer read the Resolution by title into the record.

Councilmember **Gribi** made a motion to approve Resolution 2015-X and was seconded by Councilmember **Powell**. There was no vote.

Councilmember **Pierce** made a motion to table Resolution 2015-X for additional information and was seconded by Councilmember **Gribi**. All were in favor.

## **ORDINANCE 2015-7 First Reading**

An Ordinance of the Town of Eatonville, Washington, amending Eatonville Municipal Code by deleting sections 10.08.070 and 10.08.080 so as to maintain a uniform speed limit of 25 miles per hour on Town streets.

Town Clerk Kathy Linnemeyer read the Ordinance by title into the record.

Councilmember **Gribi** made a motion to approve the first reading of Ordinance 2015-7 and was seconded by Councilmember **Pierce**. There was no vote.

Councilmember **Gribi** made a motion to table Ordinance 2015-7 until September 28, 2015 and was seconded by Councilmember **Schrimpsheer**. All were in favor.

## **COUNCIL MEMBER COMMENTS**

Councilmember **Schrimpsheer** thanked all the volunteers who helped with the 9/11 Day of Service.

Councilmember **Gribi** thanked everyone who helped with the 9/11 Day of Service.

Councilmember **Walter** thanked everyone for their hard work on Saturday and stated that he didn't see any activity at the Cemetery so he raked branches while he was there.

Councilmember **Pierce** announced that he helped with the 9/11 Day of Service for a couple hours and that he loved the event because it shows the community coming together. He also reminded everyone that the event is to remember 9/11.
