**Summary:** Chapter 16.54 of the Eatonville Municipal Code (EMC) contains the Town's stormwater management and erosion control laws. Section 16.54.020 currently adopts the 2005 Pierce County Stormwater Management and Site Development Manual as the governing text of the Chapter. However the 2005 manual is no longer the most current manual used by the Washington State Department of Ecology and the Town's planning commission recommends use of the most current manual.

**Recommendation:** Staff recommends adoption of Ordinance 2018-12, amending EMC Section 16.54.020 by adopting the most current Washington State Department of Ecology Stormwater Management Manual for Western Washington.

**ORDINANCE NO. 2018-12**

**AN ORDINANCE OF THE TOWN OF EATONVILLE,  
WASHINGTON, ADOPTING THE MOST RECENT VERSION OF  
THE STORMWATER MANAGEMENT MANUAL**

**WHEREAS**, Chapter 16.54, Stormwater Management and Erosion Control, of the Eatonville Municipal Code protects the Town from the adverse effects of erosion and sedimentation caused by development and redevelopment; and

**WHEREAS**, the 2005 Pierce County Stormwater Management and Site Development Manual, adopted by Eatonville Municipal Code Section 16.54.020, is no longer the most up to date manual used for purposes of stormwater management and control and the Eatonville Planning Commissions recommends use of the most recent manual; and

**WHEREAS**, the Town desires to use the most recent and up to date stormwater management and control manual; now, therefore,

**BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF EATONVILLE  
AS FOLLOWS:**

**Section 1.** Eatonville Municipal Code Section 16.54.020, is hereby amended to read as follows:

**Stormwater Management and Site Development  
Manual adopted.**

The ~~2005 Pierce County most current Washington State Department of Ecology Stormwater Management and Site Development Manual for Western Washington~~ is adopted and made a part hereof as though fully set forth in this chapter.

**Section 2.** Should any section, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this Ordinance be preempted by state or federal law or regulation, such decision or preemption shall not affect the validity of the remaining portions of this Ordinance or its application to other persons or circumstances.

**Section 3.** This ordinance shall take effect after publication of a summary,

consisting of the title, pursuant to RCW 35.27.300.
