Summary: Since 1990 the Town has had an Airport Commission with duties set forth in Chapter 2.35 of the Eatonville Municipal Code. The Town Council now believes the duties charged to the Airport Commission would be more efficiently and effectively handled by a Council Committee, as opposed to a commission. The attached Ordinance would eliminate the Town of Eatonville Airport Commission and repeal, in its entirety, Eatonville Municipal Code Chapter 2.35, which is the code chapter establishing the commission and setting forth its duties.

Recommendation: Staff recommends adoption of Ordinance 2018-5 eliminating the Town of Eatonville Airport Commission and repealing Chapter 2.35 EMC.

ORDINANCE NO. 2018-5

**AN ORDINANCE OF THE TOWN OF EATONVILLE,
WASHINGTON, ELIMINATING THE TOWN OF EATONVILLE
AIRPORT COMMISSION AND REPEALING EATONVILLE
MUNICIPAL CODE CHAPTER 2.35**

WHEREAS, Chapter 2.35 of the Eatonville Municipal Code establishes an Airport Commission and sets forth the duties of the Commission; and

WHEREAS, the Eatonville Town Council finds that it would be more efficient and effective for the Town of Eatonville if the duties of the Airport Commission were to be discharged by a council committee as opposed to the Airport Commission; and

WHEREAS, the Eatonville Town Council finds that the public health, safety, and welfare of the Town will be served by the elimination of the Airport Commission and the repeal of Eatonville Municipal Code Chapter 2.35; now, therefore,

**BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF EATONVILLE
AS FOLLOWS:**

Section 1. The Town of Eatonville Airport Commission is hereby eliminated and Eatonville Municipal Code Chapter 2.35 is hereby repealed in its entirety.

Section 2. Should any section, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this Ordinance be preempted by state or federal law or regulation, such decision or preemption shall not affect the validity of the remaining portions of this Ordinance or its application to other persons or circumstances.

Section 3. This ordinance shall take effect after publication of a summary, consisting of the title, pursuant to RCW 35.27.300.
