AUGUST 2019 REPORT

General

I am pleased with the progress and completion of my short-term goals for the Eatonville Police Department. We have hired a new Officer, social media is up and running and successful, a new patrol vehicle is on order, the grant for ballistic helmets has been submitted, the officers' moral is at a high. I continue to provide training, mentoring, and leadership to our officers.

Public Safety Committee

A topic of discussion on Sept. 3rd was to reinstate a criminal code regarding occupying the parks after hours. Abby Gribi was going to continue to research the laws with the Bonney Lake prosecutor. Extending the no parking zones on Center St. at Orchard and Rainier streets was also discussed. I was in favor of the modification due to poor visibility when attempting to turn onto Center from either street.

Management Activities

I am pleased to announce our new Officer, Saul Duran. He is in his third week of field training and we are proud of his success. Duran is making the transition from Washington State Patrol policing model and adapting well to our Town of Eatonville policing. It appears he will be a great asset to our Department and the Town of Eatonville.

We are researching a contract with Department of Corrections (DOC) to provide them a part-time work space to facilitate more effective and collaborative investigations and proactive enforcement of clients under DOC supervision (it will not be a space open to the DOC clients).

Also, being researched is the return of a Reserve Officer program. This would provide enhanced police coverage at a fraction of the cost of a full-time employee.

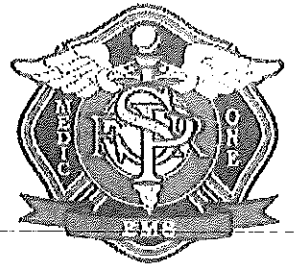
August 2019 Water Sewer Work List Synopsis

- Daily meter reads move in/outs.
- Locates as requested around town
- Fill pot holes around town.
- Repair several water leaks around town
- Train employees at both water and wastewater plants
- Clean sewer lift stations

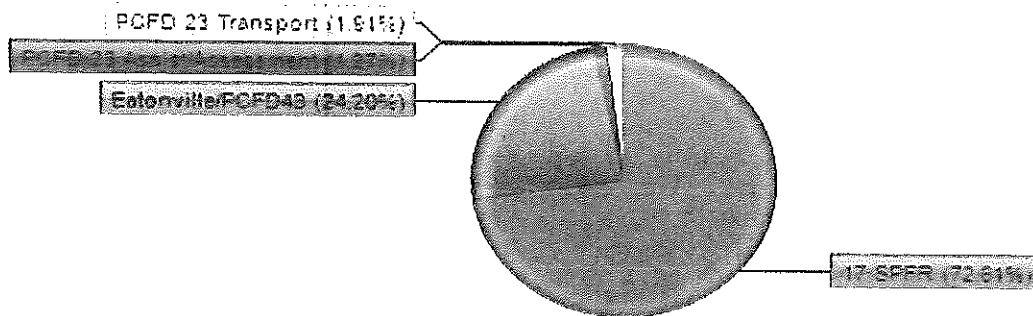


August EMS Zone Breakdown
