

**RESOLUTION 2020-B**

**A RESOLUTION OF THE TOWN OF EATONVILLE, WASHINGTON,  
AMENDING ATTACHMENT A TO THE OPERATIONAL SERVICE  
AGREEMENT WITH PIERCE COUNTY FIRE PROTECTION  
DISTRICT NO. 17, DBA SOUTH PIERCE FIRE AND RESCUE**

**WHEREAS**, on November 25, 2019, the Eatonville Town Council adopted Resolution 2019-X approving the terms of an Operational Service Agreement between the Town and South Pierce Fire and Rescue (hereinafter referred to as “SPFR”) for fire suppression and prevention, emergency medical services and administrative services (the Agreement); and

**WHEREAS**, pursuant to the terms of the Agreement the Town agreed to surplus and transfer two fire trucks to SPFR, as described in Attachment A to the Agreement; and

**WHEREAS**, the VIN numbers listed in the Attachment A approved by the Eatonville Town Council were incorrect; and

**WHEREAS**, the VIN numbers have been corrected on the Amended Attachment A and are listed below; a copy of Amended Attachment A is attached hereto as Exhibit A; now, therefore,
