JANUARY 2020 REPORT

General

I have added a statistic of “verbal warnings” to the traffic stops category. I have fielded a couple of isolated complaints that EPD is only concerned with generating revenue from their traffic stops. Although I don't believe this is a legitimate issue (based on my evaluation of the statistics), I wanted to make this information available and easily accessible to the mayor, town manager, and town council in the event it becomes relevant.

Public Safety Committee

There was no public safety committee meeting in January. Congratulations to the newly appointed committee members.

Management Activities

I am continuing the research and grant writing for auto license plate readers (LPR) for one or more of our officer's patrol vehicles. The LPRs will be a great asset and assist Officers in identifying stolen vehicles without the need to type in plates manually.

I sent an EPD uniform patch, challenge coin, and letter of encouragement to Zachariah Cartledge in Florida. Zachariah is a Facebook sensation who fundraises for fallen first responders. Every time a first responder is killed in the line of duty, Zachariah runs one mile in their honor while carrying either a blue line or red line American flag. He recently ran for Deputy Dyson of the Pierce County Sheriff's Department. More details were posted on the EPD Facebook page on January 22nd.

I am researching scholarship opportunities for EPD to participate in. I am developing a “Eatonville Police Dept. Core Values Scholarship” of which students can be nominated by fellow students or Eatonville H.S. staff. The submissions would entail a submission in writing of how the nominee meets, demonstrates, or emulates all or one of EPD's core values; Professionalism, Ethics, Accountability, Compassion or Excellence. Donates would be sought from local or regional businesses. The plan is to award up to five awards of approximately \$500 each.

We are proposing a contract with the Department of Corrections (DOC) to allow them part-time use of an office space located in the bottom floor of the Town Hall. The space would not be occupied by DOC more than seven days per month. Fees and other parameters would apply as outlined in the contract.

We are grateful to our generous citizens who voted to approve our levy lid lift.

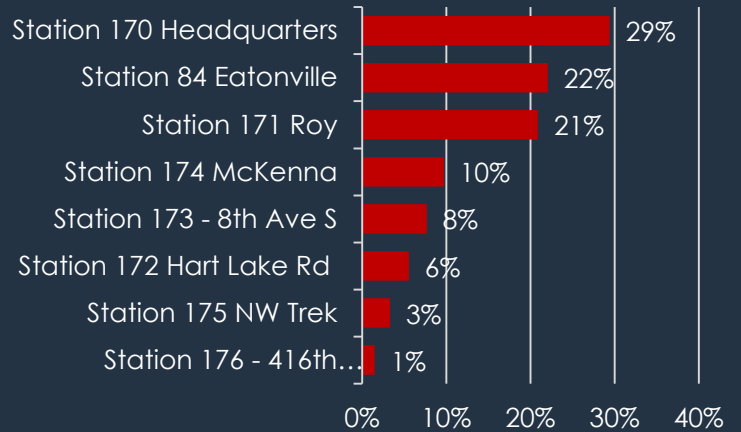

2019 - Percentage of Responses from Fire Stations

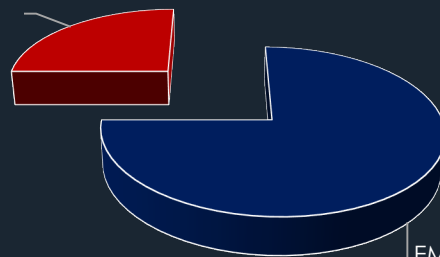


South Pierce Fire & Rescue covers over 140 square miles. With this large area we arrived to 90% of our calls in...
