SOUTH PIERCE FIRE AND RESCUE

- The District will be hiring three additional Firefighter/Paramedics in 2020, improving our service level for our citizens. We have conducted the testing and are currently performing background investigations before making any final offers. Our goal is to enroll the three candidates in the Bates Spring Fire Academy beginning in April.
- To improve our daily organizational communication, we have begun using a video conferencing program every morning to share information and plan out the day's activities. To that same end, the Fire Commissioners are considering temporarily leasing a facility in Eatonville to consolidate all the fire department administrative staff in one office building.
- The District has scheduled March 30 and 31 to conduct a similar testing process for Fire Chief as the last testing process. We have two new candidates to evaluate. one from the local area and the other from out of State.
- The District has issued a detailed Directive on protecting our staff against contracting the COVID-19 in situations where we may treat or transport a potential infected patient.
- The District has scheduled a Roll-In Ceremony for our newest Medic Unit located at the Eatonville Fire Station. The ceremony will begin at 2:00 pm on March 9, 2019

- Daily water and wastewater water quality laboratory testing and system checks.
- Daily Water and wastewater treatment quality assurance / quality control laboratory testing
- Daily pick up garbage in parks

- Daily meter reads move in/out.
- Locates as requested around town
- Fill pot holes around town.
- Train employees at both water and wastewater plants
- Clean sewer lift stations
- Various afterhours WTP and WWTP alarms
- Install several street signs around town
- Inspect new Water / Sewer connections.
- Several meetings with contactors about new projects that are starting.

I have added a statistic of “cases forwarded to PCSD CIB” to assist in tracking cases which will be assigned and worked by the Criminal Investigation Bureau as part of our contract agreement.

Management Activities

I am continuing the research and grant writing for auto license plate readers (LPR) for one or more of our officer's patrol vehicles. The LPRs will be a great asset and assist Officers in identifying stolen vehicles without the need to type in plates manually.

Officer Duran was awarded a Commendation Letter at the February 24th Town Council Meeting.

The MOU with Department of Corrections is complete, and they have started occupying their allocated space.

Eatonville Elementary School has agreed to participate in our EPD Core Values award program and we should be recognizing the first student recipient in March.
