MAY_2020 REPORT

General

We, in law enforcement, are in trying times. In response to the current events I provided a statement (below) to the public on EPD's Facebook page which sums up my thoughts.

A message from Chief LaLiberte:

I was asked by a citizen to provide my thoughts on the death of George Floyd and post them to this page. My first inclination was to decline. I didn't want to provide a platform for the Internet "trolls" to post hateful and unproductive comments. But as I watched the riots unfold in Seattle and across our nation, and as I scrolled through the myriad of statements and comments from various city leaders and heads of departments, I felt the duty to reach out the community with my message.

The death of George Floyd is a tragedy. It is a failure and a black eye on law enforcement. What was the motivation? Was it racism? Was it ego? We may never know.

Am I angry about this? Yes, I am. Mr. Floyd should not have lost his life during his contact with these officers. The officer who was arrested for the death of Mr. Floyd is not representative of the more than 1 million law enforcement officers who suit up every day and do the right thing over and over again. They risk their lives and do not ask for recognition. They consistently perform selfless acts that never make it to the evening news. They are the protectors of our communities, the saviors of democracy, and the upholders of rights.

Tuning into the news reports, I'm angered and heartbroken to see the misdirected responses of people who are choosing to destroy their own communities and commit disgraceful crimes under the guise of the Floyd tragedy. Shame on them. This behavior does not honor Mr. Floyd. In fact, it distracts from the message.

So what about here at home? I am proud that I have the responsibility to protect the great Town of Eatonville and lead four outstanding officers. We, the Eatonville Police Department, do not tolerate racism of any kind. We uphold and operate under our core values everyday: Professionalism, Ethics, Accountability, Compassion, and Excellence. We will continue to strive to make Eatonville proud and perform our duties with integrity and honor. On the exit door of our office there is a sign that reads, "What is Your Mission Today?" Our officers are reminded each time they pass through the door that this duty to protect and serve is bigger than ourselves. We will not falter. We will not shy away from danger. We will defend those who cannot defend themselves. We will be leaders in our community. We will set the example.

Public Safety Committee

There was no public safety committee meeting in May.

Management Activities

Officer Duran notified us he will be returning from Army Reserve active duty on June 4th, 2020. He will be taking a few days off to spend with his family and then returning to duty in Eatonville. We are excited for his return. He is excited as well, especially since he will be united with his new patrol vehicle.

As of this date (6/2/20) there have been zero incidents observed or reported in the Town of Eatonville as they relate to the George Floyd protests/riots. There were rumors of movements to "take over white neighborhoods" by ANTIFA and similarly aligned organizations throughout Pierce County; however, none came to fruition in our town. I continue to monitor these events and work in cooperation with the regional Joint Terrorism Task Force and the PC Emergency Operations Center.

I would like, again, to commend Officers McGuire, Anderson and Wade for stepping up during Officer Duran's absence and taking on additional shifts to fill gaps in coverage. Their dedication to our department and the community is a perfect example of their commitment, sacrifice, moral fortitude, and professionalism.

RE: Fire Chiefs Report



SOUTH PIERCE FIRE AND RESCUE

- The District is currently in the process of Grants which include, Assistance to Firefighters Grant Program COVID-19 Supplemental (AFG-S), Fiscal Year (FY) 2019 Staffing for Adequate Fire and Emergency Response (SAFER).
- The two additional Firefighter/Paramedics and one current probationary firefighter EMT are currently participating in the Bates Technical Fire Academy. This continues to improve the level and quality of our services. The Academy completion date is August 7th, 2020.
- The District has also extended the Full Time At-Will Employment to the Firefighter/EMT to continue to keep staffing at the optimum level through the Fire Academy.
- The District is still moving forward with the consolidation of all administrative staff in a leased facility in the Town of Eatonville. The project remains on hold due to the State's restrictions on new construction projects. Once the State lifts the restrictions, we will move forward with signing the lease agreement and contract for the tenant improvements.
- Due to the age of the District's SCBA's, we have moved forward and ordered the SCBA's with the expected arrival and in-service date of mid-August.
