**A RESOLUTION OF THE TOWN OF EATONVILLE, WASHINGTON,  
AWARDING A BID FOR WATER TREATMENT PLANT  
IMPROVEMENTS TO MCCLURE & SONS, INC**

**WHEREAS**, the Town of Eatonville was awarded a grant from the State Capital Budget to be administered through the Washington State Public Works Board in the amount of \$1,400,000.00 to be used for the Eatonville Third Water Filter and Clear Well Project; and

**WHEREAS**, on January 27, 2020 the Town of Eatonville entered a Public Works Board Direct Appropriation Grant Contract to construct a third water filter to the water treatment plant; and

**WHEREAS**, the Town of Eatonville solicited bids for the work according to Washington State bid laws and the lowest responsible bid was received from McClure & Sons, Inc. in the amount of \$1,148,318.20; now, therefore;

**THE TOWN COUNCIL OF THE TOWN OF EATONVILLE, WASHINGTON,  
HEREBY RESOLVES AS FOLLOWS:**

**THAT:** A contract with McClure & Sons, Inc. in the amount of \$1,148,318.20 for water treatment plant improvements is approved; and

**FURTHER THAT:** The Mayor of the Town of Eatonville is authorized to sign a contract with McClure & Sons, Inc. in a form approved by the Town Attorney.
