CALL TO ORDER

Mayor Schaub called the meeting of the Eatonville Town Council to order at 7:00 p.m.

ROLL CALL

- A. **Public Works Report** - Abby Gribi gave an update on the camera installation at the Public Works yard and the Water Treatment Plant Improvement project.
- B. **Finance Committee** – Councilmember Dunn let the Council know the Committee had met to review Small Business Grant applications.
- C. **Mayor’s Report** – Mayor Schaub informed Council that the Wastewater Plant has received an award for outstanding results. This is the 14th year in a row that the Town of Eatonville has accomplished this. They were one of 125 out of 300 to be in full compliance. The Town has given the last of the information required for the DOR audit and will be scheduling the State Auditor Office audit for 2018-2019 in September. The Water Department fixed the leak that was on Mashell Ave N/Lynch St W.

COUNCIL MEMBER COMMENTS

Councilmember McFadden was glad to hear they fixed the water leak, and is happy to hear about the water plant. She thanked everyone for coming.

Councilmember Dunn piggybacked on Councilmember McFadden’s comment, and felt it was an excellent job by the Wastewater Department.

Councilmember Walter will look for Steve McKasson to congratulate him, mentioned that Peirce County’s Covid-19 numbers have dropped, and that is good.
