## SOUTH PIERCE FIRE AND RESCUE

- Majority of SPFR Career, Volunteer firefighters, and Support Staff have received their $1^{\text {st }} \&$ $2^{\text {nd }} \mathrm{COVID}$ shots.
- SPFR currently have 11 people in the March 2021 academy. We are investigating running our own academy in 2022.
- Remodel of Station 170 is complete. Reallocation of storage space is underway with crew input.
- SPFR has entered Impact Bargaining with Local \#726 for Department reorganization.
- SPFR has commenced Multi Company Operational Training (MCO) now that we have moved into Phase 2.

## General

I am proud of my officers for stepping up during the month of January and taking on extra tasks and providing support for the COVID vaccine dissemination at EHS and for participating in the multi-jurisdictional street racing emphasis.

## Public Safety Committee

There was no public safety committee meeting in January.

## Management Activities

I discovered that the Eatonville Police Department was not vetted by the Washington Association of Sheriff's and Police Chiefs (WASPC) and not Federally certified to receive discretionary grant monies.
To rectify this, I provided documentation that EPD meets the requirements for eligibility and complies with the U.S. Department of Justice's Standards for Certification on Use of Force and Safe Policing for Communities. Our application was accepted and EPD is now eligible for Department of Justice grants.

We are moving forward with the mobile fingerprint identification beta program. The vendor is working with our I.T. department to ensure compatibility and security of the systems. We anticipate getting two scanners to test for a 3 month period.
