Councilmember Dunn made a motion to approve the second reading of Ordinance 2021-2 and was seconded by Councilmember Walter. All were in favor.

A Resolution of the Town of Eatonville, Washington, authorizing the Mayor to execute a letter of agreement with the International Brotherhood of Electrical Workers, Local No. 483.

Councilmember Hannah made a motion to approve Resolution 2021-F and was seconded by Councilmember Walter. All were in favor.
