ORDINANCE 2020-4

AN ORDINANCE OF THE TOWN OF EATONVILLE, WASHINGTON, AUTHORIZING THE COLLECTION OF THE EATONVILLE EMS LEVY FOR 2021

WHEREAS, the Town Council of Eatonville has met and considered its budget for the calendar year 2021; and,

WHEREAS, the Town of Eatonville (taxing district) held a duly noticed public hearing on November 9, 2020, pursuant to RCW 84.55.120; and

WHEREAS, the district's actual levy amount from the previous year was \$114,000.66 and,

WHEREAS, the population of this district is less than 10,000; now, therefore,

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF EATONVILLE AS FOLLOWS:

<u>Section 1</u>. The dollar amount of the increase over the actual levy amount from the previous year shall be \$865.92 which is a percentage increase of 2.987% from the previous year. This increase is exclusive of additional revenue resulting from new construction, improvements to property, newly constructed wind turbines, any increase in the value of state assessed property, any annexations that have occurred and refunds made.

<u>Section 2</u>. Should any section, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this Ordinance be preempted by state or federal law or regulation, such decision or preemption shall not affect the validity of the remaining portions of this Ordinance or its application to other persons or circumstances.

<u>Section 3</u>. This ordinance shall take effect after publication of a summary, consisting of the title, pursuant to RCW 35.27.300.
