

**ORDINANCE NO. 2017-7**

**AN ORDINANCE OF THE TOWN OF EATONVILLE,  
WASHINGTON, AMENDING EATONVILLE MUNICIPAL CODE  
SECTION 12.20.060 REGARDING PARK VIOLATIONS AND  
SECTION 12.20.130 REGARDING PARK HOURS**

**WHEREAS**, Eatonville Municipal Code Chapter 12.20 sets forth the rules and regulations regarding the use of parks; and

**WHEREAS**, the Public Safety Committee has reviewed and recommends updating the violation section of Eatonville Municipal Code Sections 12.20.060 and 12.20.130; and

**WHEREAS**, updating Sections 12.20.060 and 12.20.130 of the Eatonville Municipal Code will streamline the enforcement process; now, therefore,

**BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF EATONVILLE  
AS FOLLOWS:**

**Section 1.** Eatonville Municipal Code Section 12.20.060 is hereby amended to read as follows:

**12.20.060 Violations**

~~A violation of this chapter shall be a civil infraction punishable pursuant to the General Penalty set forth in Chapter 1.12 of EMC.~~

Violations of this chapter shall subject the person committing the violation to the abatement remedies set forth herein, as well as the following:

- A. The first offense under this chapter shall be considered a class 2 civil infraction, punishable pursuant to Chapter 1.12 EMC;
- B. The second offense under this chapter shall be considered a class 1 civil infraction, punishable pursuant to Chapter 1.12 EMC; and
- C. The third offense, and any subsequent offense thereafter, shall be considered a misdemeanor.

**Section 2.** Eatonville Municipal Code Section 12.20.130 is hereby amended to read as follows:

**12.20.130 Hours.**

Eatonville parks shall open and close in accordance with the following schedule unless otherwise permitted by the town council or mayor or his/her designee:

- A. Skateboard Park: Shall be open at 5:00 a.m. and close ~~30 minutes after~~

at dusk.

B. Community Center: As authorized by lease or arrangement with the mayor or his/her designee.

C. All other parks: Shall be open at 5:00 a.m. and close ~~30 minutes after~~ at dusk.

**Section 2.** Should any section, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this Ordinance be preempted by state or federal law or regulation, such decision or preemption shall not affect the validity of the remaining portions of this Ordinance or its application to other persons or circumstances.

**Section 3.** This ordinance shall take effect after publication of a summary, consisting of the title, pursuant to RCW 35.27.300.
