# EATONVILLE TOWN COUNCIL MINUTES OF REGULAR COUNCIL MEETING

### CALL TO ORDER

Mayor Pro-Tem Schrimpsher called the meeting of the Eatonville Town Council to order at 7:00 p.m.

### ROLL CALL

Town Clerk Kathy Linnemeyer called the roll. The following were:

Present: Councilmembers James Schrimpsher, Bill Dunn, Bob Walter, and Jennie Hannah.

Councilmember Dunn made a motion to excuse Councilmember Thomas and was seconded by Councilmember Walter. All were in favor.

Councilmember Walter made a motion to excuse Mayor Schaub and was seconded by Councilmember Dunn. All were in favor.

Also Present: Town Administrator Abby Gribi, Town Clerk Kathy Linnemeyer, and Police Chief Brian Witt.

#### **OPENING CEREMONIES**

Mayor Pro-tem Schrimpsher led the assembly in reciting the Pledge of Allegiance to the American Flag.

The Town Clerk read the Mission Statement for the Town of Eatonville:

"The Town's mission is to create, provide and administer municipal services while protecting the present and future health, safety, and general welfare of the community."

- a. Police Report- Chief Witt announced that the Department has had a lot of illness and he is looking forward to having everyone back at work.
- **b. Public Works Report-** Town Administrator Abby Gribi reported that the cameras will be installed when we have some dry weather and that the Public Works employees are doing 150-200 locates per month for the Rainier Connect Fiber Installation project.
- **c. Finance Committee-** Councilmember Schrimpsher reported that the Finance Committee met and discussed the business licensing process.
- **d. Public Utilities Committee-** Councilmember Hannah announced that the Public Utilities Committee met and reviewed utility deposits and feels that they need to be raised, discussed late fees and budget billing. The Committee also discussed how to best use the EEI funds from Bonneville and feels that a project that will serve the most citizens will be best.

Cindy Dargan, with the Pierce County Library, announced that this is the 10<sup>th</sup> Annual Pierce County Reads and thanked the Mayor and Council for their support.
