**WHEREAS**, the Mayor has appointed Rick Adams to position #2 commencing June 14, 2016 and ending June 14, 2018; and

**WHEREAS**, the Mayor has appointed Brenden Pierce to position #3 commencing June 14, 2016 and ending June 14, 2017; and

**WHEREAS**, the Town Council wishes to confirm the appointment for positions #1, #2 and #3 of the Commission; now, therefore;

**THE TOWN COUNCIL OF THE TOWN OF EATONVILLE, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:**
