

**RESOLUTION 2016-H**

**A RESOLUTION OF THE TOWN OF EATONVILLE, WASHINGTON CONFIRMING  
THE MAYOR'S APPOINTMENT TO THE POLICE CIVIL SERVICE COMMISSION**

**WHEREAS**, pursuant to Eatonville Municipal Code (EMC) Section 2.34.010, the Town of Eatonville has established a Police Civil Service Commission (the Commission) which is composed of three persons appointed by the Mayor and confirmed by the Town Council; and

**WHEREAS**, pursuant to EMC 2.34.040, the term of office of the members of the Commission shall be for six years; and

**WHEREAS**, the six year term for position #1 of the Commission expires June 1, 2018, however, Jennie Hannah has resigned from position #1 effective immediately; and

**WHEREAS**, the Mayor has appointed Angela Wohl to fill the balance of the term of position #1 commencing April 26, 2016 and ending June 1, 2018; and

**WHEREAS**, the Town Council wishes to confirm the appointment for position #1 of the Commission; now, therefore;

WASHINGTON, HEREBY RESOLVES AS FOLLOWS:**

**THAT:** The Town Council hereby confirms the appointment of Angela Wohl to fill the remainder of the term of position #1, of the Police Civil Service Commission beginning April 26, 2016 and expiring on June 1, 2018.


