**CALL TO ORDER**

Mayor-Pro Tem Schrimpsheer called the meeting of the Eatonville Town Council to order at 7:00 p.m.

**ROLL CALL**

Town Clerk Kathy Linnemeyer called the roll. The following were:

**OPENING CEREMONIES**

Mayor Pro-Tem Schrimpsheer led the assembly in reciting the Pledge of Allegiance to the American Flag.

The Town Clerk read the Mission Statement for the Town of Eatonville:

Council member **Gribi** moved approval and was seconded by Council member **Walter**. All were in favor.

### DEPARTMENT HEAD/COUNCIL COMMITTEE/BOARD/COMMISSION REPORT

- a. **Police Report-** December report is on file with the Town Clerk. Chief Heishman reported that the department has extended the hours of processing CPL's to Tuesday and Wednesday from 9am to 4pm. He also reported that the Pierce County Sherriff was dispatched, after hours, for a stolen vehicle. They were able to respond and recovered the vehicle in 20 minutes.
- b. **Fire Report-** December report is on file with the Town Clerk. Deputy Chief Grant reported that the department responded to a fire with South Pierce and Graham Fire at 204 Rainier Ave North. The fire was small, and there was limited damage, but it did produce a lot of smoke.
- c. **Public Works Report-** December reports are on file with the Town Clerk. Administrator Beagle informed Council that the new speed limit signs will be installed on January 21, 2014 on SR 161. He also informed Council that the Community Center doors have been delayed by the manufacturer and are expected to arrive at the end of January, and interviews will begin for the Meter Reader position later this week.
- d. **Public Safety Committee-** Council member **Schrimpsheer** informed Council that the Public Safety Committee met on January 6, 2014. They discussed the parking Ordinance on Mashell Avenue and possible solutions to address the issue. They also discussed putting speed bumps in the street, in front of Mill Pond Park, and reducing the speed limit for safety. Fire Chief Vellias reported damage to an apparatus due to trees in the alleys.

### RESOLUTION 2015-A

A Resolution of the Town of Eatonville, Washington approving a legal services agreement with the law firm of Joyce Ziker & Parkinson.

Town Clerk Kathy Linnemeyer read the Resolution by title into the record.

Council member **Gribi** made a motion to approve Resolution 2015-A and was seconded by Council member **Walter**. All were in favor.
