- a. **Police Report-** March report is on file with the Town Clerk.
- b. **Fire Report-** March report is on file with the Town Clerk. Chief Hudspeth informed Council that he attended class with a pilot who participated in the Oso landslide rescue and also participated in the Active Shooter Drill in Eatonville last year. The Pilot said he was able to use the knowledge gained during the Active Shooter Drill in Eatonville while participating in the Oso Landslide.
- c. **Public Works Report-** March reports are on file with the Town Clerk. Administrator Beagle reported that the Blanchard Trail has gone out to bid and bids are due on May 5, 2014. All contractors will be required to attend a pre-bid meeting.
- d. **Mayor Report-** Mayor Schaub announced that the Town of Eatonville has received the 2014 Well City Award from AWC and congratulated the employees for their efforts. The Town will receive a 2% discount on insurance premiums in 2015. He also announced that there will be a Budget Retreat on April 26, 2014 at NW Trek that will start at 9:00 A.M. Anyone attending must be at the front entrance by 8:30 A.M.
- e. **Public Safety Committee-** Council member **Gribi** stated that the Public Safety Committee met on April 7, 2014 and is working on increasing citations to cover Court costs and the possibility of a curfew for minors.
- f. **Legislative Committee-** Council member **Schrimpsheer** informed Council of the 2014 Open Government Trainings Act, handed out copies of the Act and updated Council on the status of the recreational marijuana laws.
