

**EATONVILLE TOWN COUNCIL  
MINUTES OF REGULAR COUNCIL MEETING**

**CALL TO ORDER**

Mayor Harper called the meeting of the Eatonville Town Council to order at 7:00 p.m.

**APPROVAL OF AGENDA**

Council member **Schaub** moved approval and was seconded by Council member **Gribi**. All were in favor.

Citizen Linda Custer with the Share and Care House and Pierce County Homeless Coalition announced that this is the 30<sup>th</sup> anniversary of Homeless Week. She gave a report on homeless people in Pierce County and announced that they are struggling to provide services and asked for Council Support.

## **ORDINANCES AND RESOLUTIONS**

### **ORDINANCE 2013-13 Second Reading**

An Ordinance of the Town of Eatonville, Washington, repealing any Ordinances in conflict thereof and authorizing the collection of the Eatonville EMS Levy for 2014.

Town Clerk Kathy Linnemeyer read the Ordinance by title into the record.

Council member **Pierce** made a motion to approve the second reading of Ordinance 2013-13 and was seconded by Council member **Gribi**. All were in favor.

### **ORDINANCE 2013-14 Second Reading**

An Ordinance of the Town of Eatonville, Washington, repealing any Ordinances in conflict thereof and authorizing the collection of the Eatonville Regular Tax Levy for 2014.

Town Clerk Kathy Linnemeyer read the Ordinance by title into the record.

Council member **Schrimpsheer** made a motion to change the 2014 actual levy amount to \$480,231.24 and was seconded by Council member **Bowman**. All were in favor.

Council member **Gribi** made a motion to approve Ordinance 2013-14 and was seconded by Council member **Bowman**. All were in favor.

### **ORDINANCE 2013-15 First Reading**

An Ordinance of the Town of Eatonville, Washington, adopting interim regulations concerning the production, processing, and retail sale of recreational marijuana and amending title 18 of the Eatonville Municipal Code by amending chapters 18.02 “definitions,” 18.04 “district regulations,” and adding a new chapter 18.12 “recreational marijuana.”

Town Clerk Kathy Linnemeyer read the Ordinance by title into the record.

Council member **Gribi** made a motion to approve the first reading of Ordinance 2013-15 and was seconded by Council member **Schaub**. All were in favor.

**ORDINANCE 2013-16 First Reading**

An Ordinance of the Town of Eatonville, Washington, amending Eatonville Municipal Code chapter 5.04 "Business License" in response to the state and federal actions relating to Marijuana.

Town Clerk Kathy Linnemeyer read the Ordinance by title into the record.

Council member **Gribi** made a motion to approve the first reading of Ordinance 2013-16 and was seconded by Council member **Schaub**. All were in favor.

**COUNCIL MEMBER COMMENTS**

Council member **Gribi** thanked and congratulated Officer Wade on receiving the Tacoma Pierce County DUI award.

**ADJOURNMENT**

Council member **Gribi** moved to adjourn and was seconded by Council Member **Schaub**. All were in favor. Mayor Harper adjourned the meeting at 7:45 PM.
