MINUTES OF REGULAR COUNCIL MEETING**

CALL TO ORDER

Mayor Harper called the meeting of the Eatonville Town Council to order at 7:00 p.m.

ROLL CALL

- a. Public Works Report- Administrator Doug Beagle reported that the Food Bank storage building has been completed and will have the final inspection with CDBG tomorrow. He also announced that the Salmon Festival will be held at Mill Pond park on Saturday October 19th from 10:00 AM to 3:00 PM.
- b. Lori Culver with the Eatonville Family Agency informed Council that October is Domestic Violence month. She explained the services that the Agency provides to domestic violence victims and said that the biggest need is short term housing. She asked for the support of the community by referring anyone they suspect may be a victim of domestic violence to the Family Agency.

ORDINANCE 2013-12 (Second Reading)

RESOLUTION 2013-KK

A Resolution setting a fee schedule for late payment, utility reconnection, and after hours reconnection and repealing Resolution 1999-OO.

Council member **Pierce** made a motion to approve Resolution 2013-KK and was seconded by Council member **Gribi**. All were in favor.

RESOLUTION 2013-LL

A Resolution of the Eatonville Town Council to approve an interlocal agreement with the Association of Washington Cities (AWC) Employee Benefit Trust (EBT) to provide a health care program.

Town Clerk Kathy Linnemeyer read the Resolution by title into the record.

Council member **Gribi** made a motion to approve Resolution 2013-LL and was seconded by Council member **Schaub**. All were in favor.

COUNCIL VACANCIES

Council member **Bowman** made a motion to nominate James Schrimpscher to Council position #5 and was seconded by Council member **Pierce**. The motion passed with Council member **Gribi** voting no.

COUNCIL MEMBER COMMENTS

Council member **Schaub** said he would like to see a sign at Smallwood Park identifying the pond as Ken Kildahl Kids Pond and asked for feedback from the other Council members.
