MINUTES OF REGULAR COUNCIL MEETING**

**DATE:** May 28, 2013

**PLACE:** Eatonville Community Center

**CALL TO ORDER**

Mayor Harper called the meeting of the Eatonville Town Council to order at 7:00 p.m.

**ROLL CALL**

Town Clerk Kathy Linnemeyer called the roll. The following were:

Present: Mayor Pro Tem Jim Valentine, Council members; Abby Gribi, Gordon Bowman, and Brenden Pierce.

Council member **Valentine** made a motion to excuse Council member **Schaub** and was seconded by Council member **Gribi**. All were in favor.

**OPENING CEREMONIES**

Mayor Harper led the assembly in reciting the Pledge of Allegiance to the American Flag.

The Town Clerk read the Mission Statement for the Town of Eatonville:

**APPROVAL OF AGENDA**

Council member **Gribi** moved approval and was seconded by Council member **Pierce**. All were in favor.

Council member **Gribi** made a motion to remove Resolution 2013-V and add under New Business, A Motion to Ratify Amendment to Professional Services Agreement with Larson & Associates and was seconded by Council member **Valentine**. All were in favor.

Citizen Bob Walter asked if a letter would be going out for all unlicensed animals and said he has been able to link dogs up with their owners due to our microchip scanner.

Council member Gribi announced that the Visitor Center is now open on weekends for the summer season and is looking for volunteers to staff it.

Council member Pierce stated that he appreciated all the work that went into the flower baskets and thanked the volunteers for their efforts.
