MINUTES OF REGULAR COUNCIL MEETING**

**CALL TO ORDER**

Mayor Harper called the meeting of the Eatonville Town Council to order at 7:00 p.m.

**ROLL CALL**

Town Clerk Kathy Linnemeyer called the roll. The following were:

Council member **Gribi** made a motion to approve Resolution 2013-R and was seconded by Council member **Schaub**. All were in favor.

## RESOLUTION 2013-T

A Resolution of the Eatonville Town Council to authorize the execution of a professional services agreement for surveying work at Eatonville Airport.

Council member **Gribi** made a motion to change the amount on the Scope of Services to \$13,615.00 and was seconded by Council member **Pierce**. All were in favor.

Council member **Schaub** made a motion to approve Resolution 2013-T and was seconded by Council member **Pierce**. All were in favor.
